If the licensee causes the ecolabelling organisation direct or indirect costs as a result of this or if damage is caused by a product manufactured/sold by the licensee, the licensee shall indemnify the ecolabelling organisation in full.

The ecolabelling licence is valid up to the specified date unless written notice of cancellation is issued by the licensee or the ecolabelling organisation at least three months in advance. The licence is non-transferable unless an application for transfer is submitted.
